ASIAGAP AUDITOR CANDIDATE

- Certification bodies and auditors enter into contracts.
- Required auditor training and audit experience (witnessed audits) under the certification body
- Undertake the necessary training to become an auditor.

Submit an application for ASIAGAP auditor registration*5 and documents certifying the requirements for auditor registration to **the certification body that you belong to**, and obtain a stamped seal of approval.

Required Documents

- (1) Complete the education and training courses (minimum 2 days) on general hygiene management and HACCP as required by General Regulation 11.1.3. (Attach: A copy of the certificate of successful completion).
- (2) Apply for registration with the audit record attached for each sector that is found to be good by an auditor or with a senior auditor is present to witness audit 3 or more farms. (One of the three or more audits may be a different group certification, may be substituted for two or more site audits.)

- Undertake the necessary training to become an auditor

Submit an application for ASIAGAP auditor registration form*6 and documents certifing the requirements for auditor registration to **the certification body that you belong to**, and obtain a stamped seal of approval.

Required Documents

- (1) Complete the IRCA/JRCA/RAB-approved Management System Auditor Course as required by General Regulation 11.1.2. (Attach: A copy of the certificate of successful completion).
- (2) Attach the audit record that evaluated as good; 2 or more sectors for the individual farm audits, and a total of 15 farm audits; and 2 or more group administration audits by witness a senior auditor.

(Submit application form with confirmed (stamped) registration requirements by the certification body + attached documents).



ASIAGAP SENIOR AUDITOR
